ANTI-SOCIAL BEHAVIOUR ACT 2003 – PART 4

NOTICE FOR THE DISPERSAL OF GROUPS AND REMOVAL OF PERSONS UNDER THE AGE OF 16 TO THEIR HOME ADDRESS

The local Police and the Local Authority have both agreed that there are reasonable grounds to believe that members of the public have been intimidated, harassed, alarmed or distressed as a result of the presence or behaviour of two or more persons in a public place and that anti-social behaviour is a significant and persistent problem in the below affected area.

Relevant Locality – Heanor Shown edged in red and coloured pink on the above map and bordered by:

From Loscoe Road, Heanor, follow Burns Street north east to Tudor falls. Then Head south east to the junction of Fall Road. Follow north east to the junction of Newlands Drive continuing on to Saxton Avenue where it heads south onto Market Street. The boundary then continues south east onto Church Street then north east to the junction of Holbrook Street. Follow south onto Hands Road and then go east to the junction of Lower Claramount Road. From here follow south onto Claramount Road then south east to the junction of Breach Road. Head south west crossing likeston Road onto Sunningdale Avenue to the junction of Roper Avenue. Head north west to the junction of Old Coppice Side where the boundary then heads south west to Slack Lane. Head north on Slack lane, continuing onto Thorpes Road to the junction of Derby Road. Head south west until the junction of Hallington Drive then the boundary follows north west continuing north east to the end of the road. On Monarch Way go north west to the junction of Northern Road then following north east through Johns Street onto the Loscoe Road. Finishing heading north west to the junction of Burns Street.

I, Chief Superintendent Deborah Mathews, Derbyshire Constabulary, being the relevant officer, with the consent of Amber Valley Borough Council being the relevant Local Authority, hereby authorise uniformed Constables\Police Community Support Officers (PCSO) to give one or more of the directions referred to below under Part 4 of the Anti-social Behaviour Act 2003 in the above area during the relevant period detailed below: **Relevant Period**

Directions

If, during the times and dates specified, a Constable\PCSO in uniform has reasonable grounds for believing that the presence or behaviour of a group of two or more persons in any public place in the relevant locality has resulted, or is likely to result, in any member of the public being harassed, alarmed or distressed, he/she may give one or more of the following directions, namely:-

(a) Requiring the persons in the group to disperse (either immediately or by such time as he may specify and in such way as he may specify),
(b) Requiring any of those persons whose place of residence is not within the relevant locality to leave the relevant locality or any part of the relevant locality (either immediately or by such time as he may specify and in such way as he may specify), and
(c) Prohibiting any of those persons whose place of residence is not within the relevant locality from returning to the relevant locality or any part of the relevant locality for such period (not exceeding 24 hours) from the giving of the direction as he may specify;

If, between the hours of 9 pm and 6 am, a Constable\PCSO in uniform finds a person in any public place in the relevant locality who he/she has reasonable grounds for believing (a) is under the age of 16, and (b) is not under the effective control of a parent or a responsible person aged 18 or over, he/she may remove the person to the person's place of residence unless he/she has reasonable grounds for believing that the person would, if removed to that place, be likely to suffer significant harm.

A person under the age of 16 may still be given a direction under (a) to (c) above provided that a Constable/PCSO in uniform has reasonable grounds for believing that the presence or behaviour of the person under the age of 16 in a group of two or more persons in any public place in the relevant locality has resulted, or is likely to result, in any member of the public being harassed, alarmed or distressed.

A person who knowingly contravenes a direction given to him under Part 4 of the Act commits an offence and is liable on summary conviction to (a) a fine not exceeding £2,500, or (b) imprisonment for a term not exceeding 3 months, or to both.
