

FOUR SIMPLE STEPS

1. CONTACT YOUR SOLICITOR

via the number or email address below to make an appointment for November. Please do this in good time as solicitors are often very busy during this month.

2. WRITE DOWN A LIST OF YOUR ASSETS

(your house, possessions and money) and details of the people you would like to inherit them. Once you have provided for your loved ones you could also consider making a gift to charity. Many people find great comfort in knowing that a cause close to their heart will benefit once they have passed away.

3. MEET YOUR SOLICITOR

to give him or her your instructions. If your instructions are complicated, or you need additional advice about inheritance tax planning, your solicitor will advise whether any extra work and related fees are needed at this stage.

4. YOUR SOLICITOR WILL DRAFT YOUR WILL

and if you haven't already made your donation online at our website, you can give it to your solicitor who will pass it on to us.



LIFE CHANGING WORK IN THE UK AND AROUND THE WORLD

The money raised by the Will Aid campaign is shared by the nine participating charities. Since Will Aid was founded in 1988, the campaign has raised millions of pounds to help thousands of people both in the UK and across the world to change their lives for the better.

In 2013 Will Aid solicitor Naomi Pinder, visited Haiti with a team from Christian Aid to see Will Aid donations in action.

For retired Will Aid solicitor Mark Summers, learning he had prostate cancer came with a number of other problems. He needed radiotherapy five days a week for seven weeks – at a hospital over an hour's drive away.

Mark had no idea how he would manage the travel. Until Red Cross volunteers stepped into help – giving him a lift to and from the hospital daily.

Since the civil war began in 2011, thousands of children and their families have fled the conflict in Syria to neighbouring countries.

Save the Children has been supporting many of these families, including Nadia's. Nadia and her parents have been living in a small, tented refugee settlement on the Syrian border. The whole family have received support to help them buy the food, water and medicine they need to survive.
