It will highlight responsibilities of the worker relating to Health and Safety Law, COSHH and personal hygiene, including effective hand washing. The learner will have a better understanding of what infection control is. They will be able to identify appropriate and legislation Act's which relate to infection control and which responsibilities they have in ensuring infection control procedure are adhered to. The learner will understand about types of infections, some signs and symptoms, Communicable diseases and the chain of infection and their role in preventing the spread of infection in the care setting.

The purpose of Peg feed training is to equip the learning with knowledge and understanding about why Peg feeding may be used, what its purpose is and how it can be used safely. The learning includes different types of percutaneous endoscopic Gastronomy. The course looks at the equipment used, how to set up feeds and deals with arising issues.
